SMS PRIVACY POLICY

This SMS Privacy Policy (this “Privacy Policy”) describes how we at Copper Creek of Riverview HOA, Inc. (“Copper Creek of Riverview HOA, Inc.,” “we,” or “us”) collect, use, and disclose your personal information in connection with your use of the services to receive short message services and/or multimedia services from us through the Constant Contact, Inc. platform (“SMS Services”). INFORMATION COLLECTED ABOUT YOU

Personal information we collect about you through your use of the SMS Services may include first name, last name, mobile number, address, and email address.

We may use cookies or similar technologies on our website or websites associated with the SMS Services to automatically collect your interactions with any URL links included in the Messages.

USE OF PERSONAL INFORMATION FOR SMS SERVICES

We use your personal information to provide you with community announcements, notices, reminders, emergency notifications, and other information relevant to the Copper Creek community through the SMS Services, subject to your consent.

DISCLOSURE OF PERSONAL INFORMATION

We may use third-party service providers to assist us in providing the SMS Services and delivering community communications to you, and we may disclose information to such service providers as necessary for these purposes.

- Notwithstanding anything set forth in this Privacy Policy, we do not share text message opt-in consents or related mobile telephone numbers with third parties, except with our service providers and vendors as necessary to provide the SMS Services.
- Please review Constant Contact’s Customer Data Notice for information about how Constant Contact uses your information.

We may also disclose your personal information as necessary to comply with applicable law or regulation; respond to a subpoena, court order, or other lawful request for information; facilitate a change in Association management or service providers; or otherwise protect the rights or property of the Association.

OPTING OUT

If you wish to stop receiving text messages from us, reply STOP, QUIT, CANCEL, OPT-OUT, or UNSUBSCRIBE to any text message sent from us.

ELIGIBILITY

To receive SMS Services, you must be 18 years of age or older.

We may update this Privacy Policy at any time, including to reflect changes to our practices or for other operational, legal, or regulatory reasons. Please review it periodically.
