**CERTIFICATE OF AMENDMENT TO DECLARATION OF COVENANTS,
CONDITIONS, AND RESTRICTIONS, OF COPPER CREEK OF RIVERVIEW**

THIS CERTIFICATE OF AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS, OF COPPER CREEK OF RIVERVIEW (the “Amendment”) is executed and made the day indicated below by COPPER CREEK OF RIVERVIEW HOMEOWNERS’ ASSOCIATION, INC., a Florida corporation not for profit (the “Association”).

RECITALS

WHEREAS, the DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS, OF COPPER CREEK OF RIVERVIEW, recorded in Instrument No. 2015248820 of the public records of Hillsborough County, Florida, as amended from time to time (the “Declaration”), relates to that certain real property located in Hillsborough County, Florida as described therein and which is a residential community or subdivision(s) commonly known as Copper Creek of Riverview; and

WHEREAS, the Declaration provides at Article XVI, Section 5 therein that it may be amended after the Class B Membership of the Association terminates by an instrument signed by not less than thirty (30%) percent of the Lot Owners; and

WHEREAS, the Class B Membership of the Association has terminated and the Association obtained the approval for the following described amendments to the Declaration from not less than thirty (30%) percent of the Lot Owners, whose signatures are attached hereto as Composite Exhibit “A” and incorporated herein by this reference, which signatures confirm approval from not less than thirty (30%) percent of the Lot Owners for the following described amendments to the Declaration and signify their intent to join in this Amendment to comply with the requirements of Article XVI, Section 5 of the Declaration for amending the Declaration; and

WHEREAS, the Association desires to record the following amendments and/or additions to the Declaration in the public records of Hillsborough County, Florida in accordance with the requirements of Section 720.306(1), Florida Statutes (2025);

NOW THEREFORE, the undersigned officer(s) of the Association certify and declare that the following amendments and/or additions to the Declaration are made after proper adoption of

each of such amendments and/or additions in accordance with the requirements noted above and/or which are otherwise applicable.

I. General Provisions. The foregoing Recitals are true and correct, are incorporated herein, and form a part of this Amendment as if fully set forth herein. All initially capitalized terms not defined herein shall have the definition for such terms as set forth in the Declaration. Additions to the existing provisions of the Declaration are indicated by double-underlining and deletions to the existing provisions of the Declaration are indicated by ~~strike through~~ marking. In the event of any conflict between the provisions of this Amendment and the Declaration, the provisions of the Declaration shall control.

II. Article XI, Section 7. Article XI, Section 7 of the Declaration is hereby amended as set forth below and shall provide as follows:

ARTICLE XI

COVENANTS FOR HOME MAINTENANCE

...

Section 7. Exterior Painting and Pressure Cleaning. ~~Each Lot Owner~~The Association shall be responsible for exterior painting ~~and pressure cleaning of the all~~ Homes in the Community and improvements thereon as required by the Association in accordance with this section. This responsibility shall include, but is not limited to, the selection of paint colors and types or finishes, obtaining contractor bids, scheduling and coordinating the work, and inspecting the completed work for conformity and quality. Exterior painting of all Homes in the Community is expected to be required no less frequently than every eight (8) to ten (10) years, as determined by the Board in its reasonable discretion. The Board shall convene a duly noticed meeting to determine when exterior painting shall be required and performed by the Association for all Homes in the Community. ~~It is anticipated that the Association shall require all Homes to be painted every five years. In addition, it is anticipated that the Association shall require roof, exterior walls, sidewalks, patios and driveways of all Homes to be pressured washed every three years. The Board shall convene a duly noticed meeting to determine when the uniform exterior painting and pressuring shall be required for all Homes in the Community and each Owner shall have at least 120 days to commence the work after the Association provides written notification of required painting or cleaning.~~Except as may otherwise be provided herein, each Lot Owner shall be responsible for pressure cleaning of the Home and improvements thereon as required by the Association in accordance with this section. All Lot Owners shall provide reasonable access to their Lot to facilitate the completion of any exterior painting or pressure washing work for any Homes by the Association. The costs of exterior painting shall be funded through the Association's annual operating budget(s) and paid through the Annual Assessments or Regular Assessments due by all Lot Owners to the Association for the year(s) in which such painting is to be performed. In addition, the Association may, but shall not be required to, perform periodic pressure washing of the roofs, exterior walls, sidewalks, patios, and/or driveways of all Homes in the Community to maintain or preserve aesthetic standards. The Board shall convene a duly noticed meeting to determine when such pressure washing shall be performed by the Association at any particular time or

instance but which determination shall not bind the Association to continue doing so thereafter or to do so on any particular schedule or interval. If the pressure washing of all Homes in the Community is not planned or expected to be performed by the Association and such pressure washing may otherwise be required for the Homes on one or more Lots, but less than all Lots, in the Community, each Owner shall have no fewer than sixty (60) days from the date of issuance of any written notification by the Association to complete the required pressure washing of the Home on their Lot. Each Owner shall have the right to paint or clean more frequently than required by the Association, provided that prior written approval of paint color is obtained from the Board. Notwithstanding the foregoing, by majority vote of the Members at a duly notice meeting, the Association may enter into a contract for painting or pressuring washing of all Homes in the Community and charge each Owner its equal share of the cost thereof as a Special Assessment. If any Lot Owner fails or refuses to permit painting or to pressure wash its Home or other improvements as required herein, the Association may perform the work and charge the Owner the cost thereof as an Individual Special Assessment.

III. No Further Amendments. No further amendments are made to the Declaration by this Amendment other than those set forth herein and the provisions of the Declaration shall otherwise remain in effect.

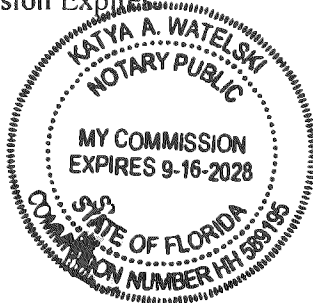

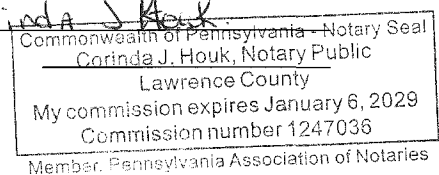

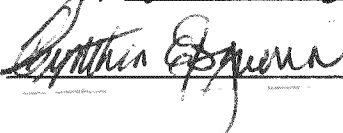
